

CIRCULAR

In view of the latest revision of interest rate by NABARD on refinance loan, the following changes in the rate of interest on lending by The WBSCARD Bank to PCARDBs and PCARDBs to their members have been made:

| All types of activities under NABARD refinance scheme except Rural Housing | 9.50 | 9.45 | 11.00 | 10.95 |
| For Rural Housing Scheme under NABARD (Irrespective of any amount) | 9.30 | 9.25 | 10.80 | 10.75 |

Incidentally, it may be mentioned here that if any female member takes loan for any purpose under NABARD refinance scheme, she shall avail 0.10% rebate on the existing rate of interest as per the prevailing practice. However, in case of default in repayment of dues on her part, normal rate of interest as applicable to all other members shall be applicable. The revised rate of interest shall be effective against all drawals made on or after 11.12.2024.
